Request for access to documents under the *Freedom of Information Act 1982 (the Act)*

1. I refer to your minute of 13 September 2013 under the *Freedom of Information Act 1982* (FOI Act) in which you have sought access to information, as below:
Complete copy of RA file held by Defence Housing Australia (DHA) pertaining to myself;
2. Paragraph 2a of your request submitted to the Department of Defence, was transferred to Defence Housing Australia (DHA) 16 September 2013.
3. I acknowledged your request 17 September 2013.
4. I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests for access to documents. My decision and the reasons for that decision are set out below.

Legislative background

5. The Act provides a right of access to information in the possession of Commonwealth agencies, limited only by exceptions and exemptions provided for in the Act.

Decision

6. I have identified a total of 89 documents listed in the attached Schedule of Documents as falling within the scope of your request. My decision for each parameter of your request appears below.
7. I have identified Documents 1,2, 8, 10, 18, 19, 23, 26-29, 31-33, 35-38, 41, 47-49, 51, 52, 54-56, 60, 62-68, 70, 71, 72,74-77, 79, 80 and 86-89 as falling within the parameters of your request and have decided to release them in full.
8. Documents 3-7, 9, 11-17, 20-22, 24, 25, 30, 34, 40,42-46, 50, 53, 57-59, 61, 69, 73 and 78 contain personal information for the purposes of section 47F of the FOI Act. I have decided to release these documents with redactions under Section 22(1)(c) of the FOI Act.
9. Documents 82-85 are duplicates of other documents and noted as such in Attachment A.
10. I consider documents 39 and 81 to be out of the scope of your application and irrelevant to your request under section 22 of the FOI Act. I have, therefore, decided not to release these documents.

Material on which my findings are based

11. I based my findings on the following material:

- the content of the identified documents;
- the relevant provisions of the FOI Act;
- the guidelines published by the Office of the Australian Information Commission under section 93A of the FOI Act (OAIC Guidelines);
- advice from DHA staff whose duties relate more closely to the matters referred to in the document; and
- the content of your FOI request.

Reasons for decision

12. **Section 47F of the *Freedom of Information Act 1982* relevantly provides:**

- (1) A document is conditionally exempt if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).
- (2) In determining whether the disclosure of the document would involve the unreasonable disclosure of personal information, an agency or Minister must have regard to the following matters.
 - a) The extent to which the information is well known;
 - b) Whether the person to whom the information relates is known to be (or to have been associated with the matters dealt with in the document;
 - c) The availability of the information from publicly accessible sources;
 - d) Any other matters that the agency or Minister considers relevant.

13. Upon examination of documents 3-7, 9, 11-17, 20-22, 24, 25, 30, 34, 40, 42-46, 50, 53, 57-59, 61, 69, 73 and 78, I have found that the documents contain the personal information of third parties and are conditionally exempt under section 47(2).

14. Section 11A(5) of the FOI Act requires me to, nevertheless, give the applicant access to the information unless, in the circumstances access to it would be at the time and, on balance, be contrary to the public interest. I have weighed the factors for and against the release of this information and decided that it is not in the public interest to release it. The factors affecting my decision include that it is neither well known nor readily available from publicly accessible sources. I consider that there is a public interest in the protection of personal information which was provided to DHA in confidence.

15. Where a decision is made to refuse access to a document, the release of a copy of the document with the exempt matter deleted should be considered under section 22(1)(c) of the FOI Act. Accordingly, I have decided to release a copy of documents 3-7, 9, 11-17, 20-22, 24, 25, 30, 34, 40, 42-46, 50, 53, 57-59, 61, 69, 73 and 78 with redactions of the personal information.

Liability to pay charges

16. I have decided not to impose any charges.

Rights of review

17. If you do not agree with my decision in relation to the release of documents you are entitled to apply for an internal review of the decision and/or an external review by the Australian Information Commissioner. Information on your review rights is at Attachment B.

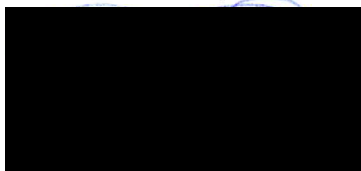
FOI disclosure Log

18. In accordance with requirements of section 11C of the FOI Act, Defence Housing Australia is required to publish, on its website, information released under the FOI Act within 10 working days of the applicant being given access to documents. Defence Housing Australia will also publish the decision notice, with any personal and business information deleted. The information published does not include personal information or the business, commercial, financial or professional affairs of any person if publication of that information would be unreasonable. Other information not published also includes that which the Australian Information Commissioner determines is unreasonable to publish.
