To whom this may concern,

I am writing in regards to an eligibility of a DHA home. I am currently a member with dependant, and am living in an unrecognised de facto relationship. My partner and I are both in the Royal Australian Navy, and are currently living in a mortgaged unit in Rockingham. I purchased the unit in April 07. The mortgage is in his name only.

My concerns are if we are eligible to have a DHA home in the vicinity of HMAS Stirling. The unit in which we are living is a 2 bedroom, 1 bathroom.

We have a 7 month old baby, and require a bath, as our bathroom hasn't a bath, nor the room to have one. We have been getting by with purchasing the largest Baby Bath we could find, and as she is growing fast, she will soon be surpassing the size of this temporary Baby Bath.

Another concern is the cramped living conditions we are all in, as baby furniture, toys and necessities regarding a baby are overwhelming, and simply haven't any room to store these items. The demands and common milestones of our baby are fast outgrowing the space we have, re no grassed back yard, or front yard, as we only have bricked paved patio, and is all covered by STRATA for the unit complex, so any additions need to be approved, and can be a long, arduous and unnecessary costly exercise.

There is no special space where our baby can play, learn and be safe. We have had to isolate her in a Baby playstation, which is stationary, and also place her in a portable cot to prevent her from injuring herself, as our floors are tiled and not soft enough to prevent her from harming herself in the event of falling.

and I are both working ashore at the moment, and with that we are both enrolled in Navy orientated compulsory courses. As the units size does not facilitate room or a quiet enough space for home study, it is difficult to maintain focus on tasks required to pass exams etc.

purchased the unit without the foresight of becoming a father as soon as he did. We have thought of selling the property, though in todays market it would not be beneficial to break contract with the lending agents, and in effect lose money. We are also unable to borrow enough money to purchase a more suitable property, as this avenue has also been investigated within the last month.



We are isolated from immediate family, which in the event of family visiting from interstate, they are not able to stay close with us, and in turn have to pay the costly monetary value of staying in a Motel, which isn't a suitable option for our family members to have to bare on their own.
