Schedule 3: Terms, conditions and limitations to which permit is subject.

Methods of interfering with wildlife specified in Schedule 1 are limited to:

Whole plants to be uprooted through mechanical process.

The purposes for which the wildlife specified in Schedule 1 may be interfered with are limited to: Removal prior to clearing and relocation within the new development.

The wildlife specified in Schedule 1 may only be interfered with from the area/s specified in Schedule 2.

The following details relate to vehicles permitted to be used in relation to the activities under this permit:

Defence Housing Fleet vehicles

The Permit Holder shall notify the Director of Parks and Wildlife or his delegate of any change of address of the permit holder within twenty one (21) days of such change of address occurring.

The Permit Holder and Nominees will keep a copy of this permit in their possession at all times when engaged in the activity for which this permit is issued and will produce it for inspection by a Conservation Officer upon request to do so.

This permit does not authorise the holder of the permit, a nominee under the permit or a person employed or otherwise engaged by the holder of the permit or a nominee under the permit to carry out activities under the permit, to enter onto land to carry out the activities authorised by the permit without the consent of the owner or the occupier of the land or, in the case of unalienated Crown land, the Minister responsible for the administration of the Crown Lands Act pursuant to Section 60 of the Territory Parks and Wildlife Conservation Act 1976.

This permit shall remain in force until the date of expiry, unless cancelled by the Director of Parks and Wildlife pursuant to Section 59 of the Territory Parks and Wildlife Conservation Act 1976.

This permit is issued subject to the provisions of the Northern Territory Aboriginal Sacred Sites Act.

The Permit Holder is advised to contact the Aboriginal Areas Protection Authority before undertaking any activities pursuant to this permit.

Pursuant to Section 64 of the Territory Parks and Wildlife Conservation Act 1976, a person who is aggrieved by a decision made under this Part may, not later than 30 days after the date of the decision, appeal against the decision to the local court. A decision that is the subject of an appeal continues to have effect according to its tenor during the conduct of the appeal.

The permit holder shall ensure that an annual return be submitted with details to include a list of

people or businesses the cycads have been sold or distrubuted to.

Should translocation occur when soil conditions are dry, then directly translocated plants to be watered in at the new site and periodically watered until the onset of the wet season and an associated rise in soil moisture levels.

All cycads for salvage are to be labelled with a Parks and Wildlife apporved tag priot to salvage.

Cycads may only be removed from areas florammly apporved for clearing.

Severed roots of uplifted plants to be treated with a fungacide.
